I have been reading the e-mails, and have tried to keep track of the issues raised by that means, but I was also aware of exchanges which have taken place in meetings, which did not appear to be completely encompassed in the e-mail exchanges so I took the time to come up to speed in this regard as well by communications with Larry and Hal. But maybe it is now me that is experiencing some confusion. If so, I am very sorry.

I had understood that there was some issue as to the proper measurement of grade at the front of the residence to be worked out, the architects met and worked that issue out to their satisfaction, and that story poles were to be placed to allow an assessment of the possible view obstruction posed with these changes made. It was again my understanding that everyone in attendance at the last meeting on this topic understood and agreed to this handling.

I do not want you to have to wait any longer for approval to proceed with your project; that is the reason that we made the effort to confirm with the consulting architect for the Board, Richard Blumenberg, that the Plans Committee can conduct this review in his absence. Hi Steve,

Thank you for exchanging notes with the rest of the Plans Committee and Mr. Blumenberg to get the full picture of the exchanges that have taken place, and the issues addressed, since you last participated in communications on this project. I had been CC'ng you on my emails and we have had a few phone conversations so I am surprised you weren't aware of what had been taking place. We know that you had passed the handling along to Mr. Erdley and Mr. Friedman. But I'm sorry, I'm confused. I met with Mr. Erdley & Mr. Friedman and a member of our architectural team on April 4th 2014 and at that meeting they both said that there was NOT an objectionable view obstruction due to our project and if we made a pitch adjustment to our roof our project would be approved (which on their say we secured a lease that now sits empty that we are paying for) Mr. Friedman was leaving for 2 weeks and said he would let the board know this. Mr. Erdley concurred .We have made the roof change requested on April 4th (incurring additional engineering costs)

I would hope you wouldn't force us to wait on our project any longer (the PHOA has had our plans since 1/20/2014) due to Mr. Blumenberg's impending vacation. We were under the impression the story poles were for his review as Mr. Erdley had emailed on the 5/22/2014 saying that he was now our contact person for the PHOA.But since Mr. Blumenberg does not see the need to be present to view the story poles once they are erected, having met with Mr. Erdley & Mr. Friedman who you had passed the handling of our project on to and getting their approval & In light of you having been to the property on a couple of occasions and have not voiced any objections to the project and stated for your purposes alone, you are not essential to the process why should we go to yet more additional expense when it seems we should have been a go in April?
