4. Photographs of area to be affected by proposed construction or addition, if requested by the PHOA.

For **FINAL** approval:

1. 2 sets of full-sized printed plans, at 1/8" scale or larger as described above, as stamped and approved by the Department of Public Works Building and Safety.
2. Structural engineered drawings, if appropriate and requested by the PHOA.
3. All pertinent specifications, demonstrating materials to be used for all proposed work and color of all such materials. Manufacturers' samples or actual product samples, not to exceed 8" square, may be requested by the PHOA.
4. Exterior lighting and landscape plans and specifications, if involved in project.
5. Electronic files in PDF format of all such plans and materials, to be sent to the Association at [Palisair@gmail.com](mailto:Palisair@gmail.com).
