Richard Blumenberg reviewed your plans submitted on April 29. He found the following items to be addressed:

- on page A-001 please add the elevation for the new deck on the plans (489.50)
- on page A3.02 the height of the deck must be a maximum of 15'6". The height is to be measured from the slope below to the top of the deck guardrail (see attached picture).
- page A4.02 is missing the glass rail information on the exterior elevation and ext. stairs.

Robert, please submit revisions and changes to me at 563 Via de la Paz, PP. For any changed pages please submit two large copies, 2 reduced copies and a PDF.

The next meeting is Monday, May 18. If we have your changes by next Thursday we can get the project on the agenda for a vote for that meeting. If you would rather hand write in some of the changes, you are welcome to meet at my house or Richard's office to do so.
