Palisair Homeowners Association,

To the President and Members of the Board,

I wrote to you yesterday regarding the home proposed at 1111 Las Pulgas Place, owner Danny Seo has been meeting with the board concerning the design, retaining walls and so forth.

He came by our house today and observed the story poles his contractor had put up on the property. One pole indicated the house wall edge, another the retaining wall.

We are not sure that the house corner shown depicts the actual height, the roof would actually slope up higher than indicated according to the owner, to be verified with the architect.

Danny observed how much the proposed upper level of his project blocks our primary view, even without the roof slope included.

He discussed adjusting the plan to pull back the room in that location in plan so that it would block our water view.

We are planning to meet with the owner, and his architect on site to observe the story poles again and discuss ways to adjust the plans in order to mitigate this obstruction.

We would like to hear from the board on what is the protocol for this procedure, in terms of the board's involvement and jurisdiction.

Also, please let us know who to contact specifically regarding this matter, e.g. the consulting architect or another individual.

We ask that the design to be scaled back at the area of concern, we have also asked that once the plans are adjusted, we need to see revised story poles that show the actual slope of the roof along the property.

Hi Danny,

Thank you for meeting at our house tonight to see the story pole situation and how the current scheme would block our primary view from the house.

As I mentioned before, because of the wedge shape of the properties, it is critical to see on-site to understand how much the proposed area eclipses our view.

I realized that I forgot to show you the master bedroom view which I have attached along with other photos.

These photos also indicate why the next round of story pole accuracy is critical.

If the story pole only shows the height of the wall, it does not correctly show how the slope roof would obscure the view.

In our meeting you discussed working with your architect to make the necessary adjustments to the plans to mitigate this obstruction.

We look forward to meeting with you both to work out a solution.

Once plan adjustments have been made, I think a second round of story poles that depict the actual slope of the roof will be needed to clarify.

Please forward the plans as soon as possible. In terms of meeting time availability, I am available tomorrow until 5 pm, Bill is available from Thursday afternoon on.

If your architect (Phillip) would like to come by tomorrow to see the views, I can make arrangements to be here, just need an hour or so notice.
