Hi Lesley,

I met with Dawn Hill today and walked around her property. The open area on the side of the house is going to have a wood, slatted fence (like a picket fence) on top of the current retaining wall. It will not be taller than what is allowed. That fence will go along the side of the house to a certain point and then the material will turn into glass. The entire section will be enclosed up to the front

where the property begins to slope toward the street. It should be completed in the next 2-3 weeks.

The entire Hill property is enclosed by a wall or fence. I could not see the chain link fence nor access it from the back of the Hill property so I was unable to address it. I did not go onto your property and would rather do so when you are present.

The Hills have apparently maintained and paid for the trimming of the side yard hedges between the two properties where there is a view for many years. They are happy to continue to have their gardener maintain this area at their expense if you are ok with that. Please let me (or them) know.

In regard to the chain link fence, I would be happy to meet you at the property to view the open area you are concerned about. However, if it is just a matter of asking a gardener to climb up there to secure it, that may be the fastest route. I would have no way of knowing whose property the fence is on and how it came to be rolled up as I was not with the HOA at this time. That being said, I am more than willing to take a look if that would be helpful.

Please let me know if you have any other questions. I see that your property is gated otherwise on both sides so once the rear area of the chain link fence is fixed your dogs should be secure?

Thank you Kim.

I will not be at the house that day but please feel free to go on my property if needed. There is a bicycle lock (but it's not locked) keeping the white gate closed so you can just push on it after removing the lock.

As long as you're discussing fencing with them, there is also another part they removed but never replaced. It's where the chain link on the back slope

of my property met the wood fence (they removed the entire wood fence). Where our properties line up way in the back up the slope, you will see the chain link laying on the ground, partially rolled, with openings for my dogs, other animals (or people) to climb through. I climbed up and tried to fix myself, but it is way to steep and I kept sliding back down the hill.

I look forward to hearing what and when they will be replacing this (and at what height please).
