# PHOA BOARD MEETING JANUARY 18, 2015 MINUTES

**I.** President Francine Kirkpatrick called the meeting to order at 7:10 p.m. at Miriam Schulman's residence. Present: Roger Broderick, Karen Olan, Vi Walquist, Suzanne Weisberg, Francine Kirkpatrick, Miriam Schulman, David Schultz, Diana Ungerleider and Kim Bantle.

Guests present: Dawn Hill, Chuck Emerick, Howard Weisberg and Brian Bradford.

**II. Approval of 12-21-15 Minutes** Minutes from the previous meeting were reviewed. Minutes were approved as amended.

#### III. Treasurer's Report

- **a. Bank Balances** Olan reported that checking account balance is \$17,671.42 and savings account balance is \$32,407.25.
- **b. Dues delinquencies** 93 homeowners have paid their 2016 dues so far; a few have paid balances due for prior years. Olan and Walquist will send reminder letters to those who have not paid.

### IV. Membership and Governance

- **a. CC&R Rewrite** Kirkpatrick reported on results of recent survey. 31 surveys have been returned so far. Board members will go door to door if necessary to collect surveys from homeowners who did not mail them.
- **b. 2016 Annual Meeting** Kirkpatrick reported that Inspector of Elections is Melanie Bauer who will oversee ballot count on February 1, 2016 at Diana Ungerleider's home.
- **c. 2016 Election** 36 ballots have been received so far; 47 ballots are required to make election valid.
- d. Discussion held on issue of "art jury"; to be explored further.

- e. Homes for Sale and Escrows Walquist reported on recent activity:

#### V. Plans Committee

- a. PHOA Policy/ Procedures
  - i. Bantle reported that the slab survey requirement will be included in the Application Proess and Fees for Alteration or Construction.
  - ii. Discussion held on issue of electric fences. PHOA received a complaint from a homeowner about an electric fence on a neighbor's property. Electric fences are illegal in residential areas. Schultz will respond to complaint.
- **b. 1243 Las Lomas Ave. (Fabian)** Owners are seeking Preliminary Approval. Plans were received and reviewed by Richard Blumenberg. Owner is seeking a variance from LADBS-required 7 foot setback (a 1.5 foot variance on setback on side of house, which would be within the 5-foot limit required by CC&Rs). Site was visited by Kirkpatrick and Bantle and it was determined that there is no view obstruction related to the addition. Board reviewed plans.

Kirkpatrick moved to grant Preliminary Approval; Ungerleider seconded; passed unanimously.

**c. 1111 Las Lomas Ave. (Tishbi)** Owner submitted a PDF of plans for new construction but needs to submit full-size plans for review by Blumenberg. The PDF was reviewed briefly but no decision can be made until large plans are received.
