Hello Valerie,

You are welcome to come to my home but when you hear what I have to say you may not feel a need to. (BTW the board meeting was at Miriam's house, not mine.

I'm at 16050 Anoka, a few doors down). About Eliot's flat roof proposal: Our CC&Rs prohibit glare in roofing material. When Title 24 changed to include residential communities and the glaring roof was installed next door to me last year the board was convinced we, through our CC&Rs, had no way to trump LADBS's Title 24 rules and the glaring white roofs it required. However, Kim and I last week visited LADBS and talked to the head engineer about Title 24 and he confirmed what we'd been recently told that glaring roofs are not mandatory *if proper insulation is put under the roof*. This is the information I had given Elliot. I asked him for a sample of his roofing material and was very explicit with he and his contractor that we would not approve a glaring roof.

It's unfortunate that we didn't dig up this information earlier but it was buried in "Non-Residential" documents on the LADBS website.
