The Board of the Palisair Home Owners Association will be holding a Neighborhood Meeting on **Sunday, March 5<sup>th</sup>, at 2PM** to consider the application of Steve Chapin, owner of 1055 El Medio Avenue, for permission to build a home, consisting of 7,316 sq. ft. at ground level and 5,339 sq. ft. below ground, and including 5 variance requests relating to several sections of the home. The requests include construction of three sections off pad, one involving a pool, a small second story section and solar panel installation. These requests involve heights that are above the Palisair Home Owners Association's CC&R's maximum height limit of 15 ½ feet, and construction on stilts rather than a flat level pad as specified in the CC&Rs.

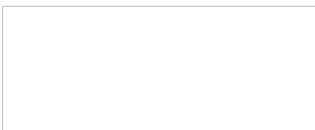
