Dear Ryan,

I am writing to notify you of a potential claim against the Palisair Homeowner's Association ("PHOA), which we are tendering to you for defense and indemnity under our insurance policy, number ANV 105126A , effective from August 1 2016 to July 31, 2017. I am attaching several emails from an attorney, Keith Turner, in which he has indicated that he might file suit and make a claim against the PHOA.

The potential claim arises out of a decision by the PHOA involving a dispute between Mr. Turner's client (Miran Kojian) and another homeowner (Miriam Schulman) involving a fence between their shared property lines that raised competing view and privacy concerns. The homeowners could not resolve their issues, so they presented a request that the PHOA consider the CC&R issues that were raised in order to then decide the issues in accordance with and pursuant to the PHOA CC&Rs. We had a meeting on July 9, 2016, at which time the PHOA board made a decision after engaging in a site visit and holding a meeting with the two homeowners. Because Ms. Schulman is a PHOA board member, she did not participate in the PHOA vote or decision.

After the PHOA decided the matter, we received the attached emails from Mr. Turner, as attorney for Miran Kojian, in which he asked for documents and then made threats of a potential claim against the PHOA, which again is why we are tendering this claim to Lloyds for defense and indemnity. After receiving the first email from Mr. Turner, asking for certain documents, PHOA board member Diana Ungerleider promptly responded in the attached email that directed him to the publicly available documents on the PHOA website. This did not satisfy Mr. Turner, who responded by sending additional emails that are aggressive in tone and provide indications of a potential claim, for which we believe it is best to tender to you for handling.

We would be happy to also send all emails and documents that we have on this matter to you and the defense attorney that is assigned to handle this matter. Please advise at your earliest convenience that Lloyds is accepting the tender of this matter, and who we should coordinate with concerning this matter. Thank you for your prompt attention to this matter.
