It has now been more than five years since we have requested that the Association enforces its view obstruction requirement per the Home Owners Association's CC&R with respect to the overgrown oleanders, one tree and a few recently planted pine trees on Steven Thomas property, 949 Las Lomas Avenue. We again request that the Association uses its authority to fully enforce the requirements it places on all home owners equally according to its CC&Rs.

As you know there is a long history to this situation. It goes back to April 24 2012, when I sent a letter to Larry Friedman, then president of the Association, requesting the Association takes action after my direct and repeated appeals to Mr. Thomas were rebuffed. The Association a year later sent a certified letter (February 26 2013) to Mr. Thomas asking him to comply with Article III, Section 9 of the CC&Rs. To my knowledge, the Association received no reply nor did it follow up with actions that are permitted by Article V, Section 3.

Since and over the years, I have attended a Board meeting to plead our situation and multiple requests to various individuals including the current president of the Association and several current and past board members to no avail, but a vague promise to talk to Mr. Thomas. The view obstruction remains to this day, made increasingly worse due to the recent rains.

Finally, according to the minutes of the Association's Board meeting of March 29, 2016, the Association committed to send another letter to Mr. Thomas with copy to me, presumably to request that he complies to the CC&Rs. This pledge was repeated at the June 20 and July 9, 2016 Board's meeting (per their minutes), but again no action has yet been taken to my knowledge.

I believe that give this history, you will agree with me that it is time for the Association's Board follows up with its commitment to enforce the CC&Rs equally in this matter as in all other matters and without any further delays.
