Dear Palisair Homeowner:

VOTING PACKET

For the election of new Board members, we have three positions to fill this year. The candidates chosen by the PHOA Nominating Committee are Miriam Schulman, Dawn Hill, and Kathy Wedeking, who are all running for reelection. (Kathy was appointed by the Board to replace Francine Kirkpatrick, our past president, who has resigned and is moving to Oregon). In addition, Michael Cohen is self-nominated. Biographies for the nominees are enclosed, as well as voting instructions and the ballot for your confidential vote. The Palisair Election Rules, adopted to comply with the requirements of the Davis-Stirling Act, can be found on our website, Palisair.org.

Because the vote for Association Directors is done solely by mail, and because no voting will take place at the Annual Meeting, no annual meeting quorum is needed. However, a full third of the Association needs to return their ballots to meet a quorum requirement to make the vote for Directors valid. We strongly encourage you to return your mail-in ballot postmarked by **January 27, 2018**. If you do not wish or feel unable to participate in the vote for Association Directors you may still help meet our quorum by marking “Abstain” on your ballot.

ANNUAL MEETING

The annual meeting of the Palisair Home Owners Association will be held at 7:00 p.m. on **Monday, February 5, 2018** in Jane Hall in Pacific Palisades Presbyterian Church, located at 15821 Sunset Blvd. The agenda for that meeting is enclosed.

The Annual Meeting of the Palisair Home Owners Association is the Association’s only all-membership meeting for the year, and we sincerely hope you will attend. It is an excellent place for you to keep up to date on the PHOA’s activities. In addition, we have scheduled an outstanding presentation at the meeting by Jeff Edelstein of SOS Survival Products, on the topic of emergency preparedness. Whether for fire, earthquake, or nuclear war, disaster survival is

very much on our minds these days, and we hope that Jeff's talk will stimulate many steps that can be taken to improve disaster preparedness in our neighborhood.

ASSESSMENT REMINDER

Since a vote by the members in 2011, the payment of dues has been **mandatory**. We are required by law to inform you of the obligation of the Board of Directors to collect the annual mandatory dues, including past-due amounts. The process is detailed in our "PHOA Assessments and Dues Collection Policy," available on our Palisair.org website. Also, please review the CC&Rs, Article VII, Assessments, Section 1, Creation of Lien and Personal Obligation of Assessments.

Your assessment (dues) bill and budget report for 2018 were mailed to you on November 1st. If you have already paid your 2018 assessment, thank you. If not, to avoid a 10% late charge and the start of 12% per year interest, your 2018 dues payment must be received no later than January 31, 2018.

For the small number of homeowners that still have assessment, late charge, and interest charges that are more than one year past due, an up to date statement is enclosed. Please be aware that the Association is planning to turn over collection of your accounts to a law firm that specializes in collecting HOA past due amounts. You will then be responsible not only for past due amounts but also for collection costs and legal costs, which start at \$300.00 for the delivery of your pre-lien letter. By paying now, you can avoid these costs.

As president, I extend my apology for the failure of previous Boards over the past few years to be more diligent in collecting the mandatory assessments from the small number of homeowners that have resisted paying. The tone of some of our communications this year regarding these past due charges has been unnecessarily abrupt. On the other hand, I am happy that by collecting a significant fraction of the past due amounts, we have put the Association well on the way to a strong financial position for the years going forward, without the need to raise the annual assessment. Please know that our \$266.00 per year assessment is comparable to that of other homeowner associations in the Palisades areas that have mandatory assessments. A number of our Homeowners have expressed the opinion that our assessment is tiny compared to the benefit provided to most of us by protecting our views while still permitting major improvements to properties.

SECOND E-MAIL ADDRESS FORM

As many of you may have noticed, starting this year we have been sending out monthly e-mails to the membership, usually four days before the monthly Board meeting on the third Monday of the month. Those of you that have not provided an e-mail address or have not authorized sending out our official notices by e-mail are sent a printed copy in the mail. The most important purpose of this monthly communication is to provide better notice of our Board meetings, in conformity to the Davis-Stirling act. In addition, we provide you with a copy of the draft minutes of the previous meeting and the agenda for the upcoming meeting.

At the December meeting, our new Board member pointed out that we should really be e-mailing to both members of households where there are co-owners. So that we can start doing so, enclosed is a revised version of the E-mail Consent Form that we sent last month, with room for two e-mail addresses.

Please fill in the revised E-mail Consent Form and include it in your ballot mailing. Please put it outside the inner envelope.

VOTING INSTRUCTIONS

December 28, 2016

Dear Palisair Home Owner:

Based on the passage of the CC&R amendments in October 2011, the PHOA is now governed by the Davis-Stirling Act, which, among other things, requires an annual secret ballot for the election of the members to the Palisair Home Owners Association Board of Directors. To be eligible to vote, you must be the legal owner of your home in one of the three PHOA tracts 15944, 15948, or 19890.

The California Civil Code provides a specific procedure to conduct the secret ballot election in order to insure fairness and participation, while insuring that your vote remains confidential. We have enclosed two envelopes in compliance with this procedure.

The ballot itself is not to be signed by you, but once you have completed it, please seal it inside the enclosed small blank envelope and then place that envelope in the second larger envelope, which is addressed to the PHOA Inspector of Elections. In the upper left-hand corner of this second envelope, **sign your name** on the signature line of the return address label, which shows your address within the Association. Even though you may prepare your ballot at some location other than the property you own within the PHOA, it is important that your signature is under the address of the property you own; this gives you the right to vote. If your name, PHOA address and signature are not on this envelope the Inspector of Elections cannot count it and will show it as voided. Once your ballot is received by the Inspector of Elections it is irrevocable.

Following the 2012 By-Laws changes, we now have a staggered Board with three-year terms. Each year, therefore, three Board positions are up for election. **This year there are four (4) candidates running for three (3) Board positions: three candidates recommended by the PHOA Nominating Committee, and one self-nomination.** (See “Biographies of Candidates” page enclosed). Therefore, **you must mark no more than three (3) “In Favor” votes. If you choose not to vote and would like (as we strongly request) to have your ballot counted toward a quorum, please mark “abstain”.**

The Inspector of Elections will be tabulating the vote to elect directors by Secret Ballot on Friday, February 2, 2018, at 7:00 p.m. in a public meeting at the home of Howard Weisberg, 16001 Anoka Drive, Pacific Palisades, CA.

We recommend that your ballot be postmarked no later than Saturday, January 27, 2018, in order to ensure its arrival before the votes are to be counted. The ballot envelopes will not be opened until the public meeting referenced above. If you are unable to mail your ballot by the deadline recommended, you may bring it in person to the vote counting meeting on February 2. **A quorum of members must return ballots in order for the vote to be valid.**

Consent for Delivery by Electronic Mail Transmission

California law requires that the Association deliver to its members certain notices and documents (collectively, "Association Notices") from time to time.

As a member of Palisair Home Owners Association, I acknowledge that I have a right to receive Association Notices in non-electronic form (e.g. via U.S. Mail). Notwithstanding the foregoing, I desire to receive in electronic form via electronic mail ("E-mail") all Association notices capable of being sent in electronic form, in lieu of receiving the same in a non-electronic form.

By signing this consent form, I represent and understand the following:

- Some Association Notices (e.g. secret ballot) must be sent in non-electronic form. I will continue to receive the same at my U.S. mail address on record with the Association.
- Association Notices capable of being sent in electronic form will be sent to me via E-mail in a format that prevents them from being altered (e.g. pdf format).
- I have the right to update my E-mail address at any time by notifying the Association in writing.
- I have the right to revoke my consent to receiving the Association Notices in electronic form at any time by notifying the Association in writing.
- Upon receipt of such revocation, the Association will resume providing all Association Notices to me in non-electronic form.
- I have the right to obtain a paper copy of any Association Notice upon request. There shall be no charge for such paper copy except to the extent permitted by Civil Code §5200, et seq.
- For purposes of giving notice, "delivery" shall be deemed complete at the time of the transmission from the Association.

To confirm my consent to receiving all Association Notices capable of being sent in electronic form via E-mail only and to demonstrate that I can access Association notices in the electronic form that will be used by the Association to transmit such information, I must (1) sign this form and return it to the Association, providing my name, property address and authorized E-mail address, and (2) later click "reply" to the confirmation E-mail I will receive from the Association.
